In continuation of the Notification issued by the Institute vide Ref. No.: NITK/Admin-Estt./COVID-19/2021/B1, dated 12-06-2021 and as per the Order No. RD 158 TNR 2020, dated 19-06-2021 of the Chief Secretary and Chairman, State Executive Committee, Government of Karnataka and as per the Order No. ಎoಎಜಿ(2)ಸೀಆರ್.156/2021/133465/ಸt/17, dated 20-06-2021 of the Deputy Commissioner & District Magistrate's

Office, Dakshina Kannada District, Mangaluru to break the chain of COVID-19 transmission in the State / District, the duty concept of work from home will remain in force up-to 05.00 AM on 05-07-2021 or until further orders, whichever is earlier. Other instructions enumerated in the notifications vide reference read 1. above shall continue to remain in operation.

However, servant maids who have been vaccinated are permitted to enter the campus by presenting their valid ID proof at the security gate. They should strictly follow COVID-19 SoPs. The concerned officials / residents of the quarters in which the servant maids are engaged in are advised to take necessary precautions while letting them in and shall be responsible for the safety of other residents of the concerned quarters.

The above guidelines will be reviewed in case of issuance of fresh guidelines by the Government (State or Central, as the case may be).

All members of the NITK community are requested to co-operate with security / emergency staff on duty to make the campus safe and secure from the coronavirus pandemic. All Head of the Department / Section / Centre / Unit are requested to bring it to the notice of all faculty members, non-teaching staff members, project staff, and students for information and necessary action.
