Withdrawal

They are required to send a copy of Bank passbook first page for account details. The email should have a subject line as: **"Withdrawal of M.Tech/M.Sc seat under CCMT/CCMN-2022".**

The email should be sent from the registered email id of the candidate under CCMT/CCMN only. The email received from any other email id will not be processed. The email sent to any other email id, other than <u>academicdocuments@nitk.edu.in</u> will not be processed.

Such candidates who have submitted the withdrawal letter as above, will be eligible for refund of the amount paid by them to CCMT/CCMN as seat acceptance fee and partial admission fee or Special round participation fee after deducting the processing fee of Rs. 1000. Please note that the registration fee paid by the candidates to CCMT/ CCMN is not refundable.

The refund will be made only to such candidates who have submitted the withdrawal request as above and whose name is in the final list sent to NITK by CCMT/CCMN for whom the fees paid at CCMT/CCMN are transferred to NITK.

The refunds will be made only after NITK receives the fee amount from CCMT / CCMN-2022, which is tentatively after 31st Dec 2022.
