**INSTITUTE'S SPOT ROUND FOR M. TECH PROGRAMMES (GATE & NON GATE CANDIDATES)**

Spot admission for the vacant seats in M. Tech programmes at National Institute of Technology Karnataka, Surathkal, for the academic year 2019-20, will be carried out as per the following schedule:

**Venue : LHC-A, Administrative Building, NITK Surathkal**

**Eligibility:**

Admission to M. Tech program shall be open to Indian Nationals who have passed the prescribed qualifying examination with a Cumulative Grade point Average (CGPA) of at least 6.5 in the 0-10 scale grading system OR not less than 60% marks in the aggregate (taking into account the marks scored in all subjects of all the University examination conducted during the entire prescribed period of the degree programme). However, this prescribed minimum shall be CGPA of 6.0 OR 55% marks for SC/ST/PwD candidates.

**For GATE Qualified Candidates**

Candidates with valid **GATE score (2017/2018/2019)** will be eligible for the Spot Round admissions. Interested students should fill the **Application form** (which will be made available at NITK website on the day of spot round), and submit the filled and signed Application form along with a copy of all required documents at **LHC-A (Lecture Hall Complex - A)** during the **prescribed date and time**. They can give their choice of M. Tech programmes in the order of preference (**Vacancy matrix will be displayed on NITK website on or before August 07, 2019**) for the Spot Round Admission and for which they are eligible to apply under CCMT based on their qualifying degree and GATE discipline (as per CCMT 2019). The application has to be submitted by the applicant in-person and all original documents must be available for verification. The allotment will be strictly based on GATE Score, academic eligibility and category to which the student belongs. Allotment will be made for all the vacant seats as on **August 09, 2019**.

**Students already admitted to any institute including NITK, Surathkal under CCMT 2019 will be permitted to participate in Spot Round only if they have withdrawn their current seat. Proof such as copy of cancellation letter need to be produced at the time of Institute's Spot Round Registration.**

**Further, seats withdrawn by the existing students at NITK Surathkal after the conduct of internal sliding can also participate in Institute's spot round admission.**

**For Non-GATE Qualified Candidates**

Non GATE candidates are instructed to directly report between 9:00 A.M. to 10:A.M. to the respective Departments with all requisite original educational credentials for document verifications and assessment through Test. Further, based on the Merit list received from the departments, shortlisted candidates will be

considered for allotment subject to availability of vacancy after close of allotment to GATE qualified candidates. The admission to Non GATE qualified candidates will be made from 4:00 PM onwards on August 9, 2019.

  3. Marks card of qualifying exam (all years )/ all semester
  4. GATE Score Card **(2017/2018/2019)**
  5. Caste Certificate issued by competent authority for SC/ST/OBC
  6. OBC Certificate in the Central Govt. format issued by competent authority on or after April 01, 2019 if applicable, The caste should be listed in the Central OBC list (National Commission for Backward Classes, [www. ncb.nic.in](http://www.ncbc.nic.in))
  7. PwD Certificate for Persons with Disability, if applicable
- The selected candidates will have to make a payment of Rs 500 (Rs 150 in the case of SC/ST/PwD) through online or **DD drawn in favour of the Director, NITK, Surathkal** payable at Surathkal, as application fee while collecting the admission orders from the Academic Section.
  - **The selected candidates have to join the program on the same day by paying relevant fee. The payment of fee has to be done ONLINE through the NITK IRIS portal. Once admitted, the fee will not be refunded if the candidate withdraws his seat.**
