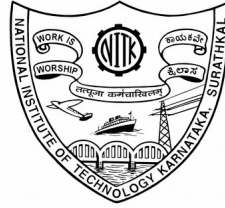

**NOTICE INVITING QUOTATIONS**

The National Institute of Technology Karnataka, Surathkal (in short - NITK, Surathkal) is an autonomous Educational Institute of the Government of India under the Ministry of Human Recourses Development imparting technical and science education. National Institute of Technology Karnataka, Surathkal is one of the “**Institutes of National Importance**” declared under the NIT Act – 2007 (Act No.29 of 2007). NITK Hostel trust is looking after NITK Hostel activities.

The NITK, Surathkal Hostels intends to purchase the hot and cold water dispenser (with storage tank) along with RO Water Filter for Kailash (Mega Tower – III). In this connection, sealed **Quotations** are invited by the undersigned subject to the terms and conditions enumerated hereunder from the manufacturers/ authorized dealers/ agencies **so as to reach this office on or before 05.09.2019 by 3:00 PM**. The quotation shall be opened on a later pre-informed date.

**Terms and conditions:**

1. The intending bidder shall quote his rates and he shall sign each page with seal of the firm. Envelope super scripted as “Quotation for **supplying hot and cold water dispenser (with storage tank) along with RO Water Filter**; Due on 05.09.2019”. and addressed to as “ NITK Hostel Office, First floor, Sahyadri (VII) Block Hostel building, NITK, Srinivasnagar, Mangaluru – 575025.” Be sent so as to reach this office on or before the due date mentioned.
2. Water dispenser with Hot Water : 10 Liters/ hour and Cold water: 10 Liters/ hour capacity and have option to directly connect to main water supply through RO water filter.
3. Equipment has to be procured with minimum **three years warranty** of comprehensive ONSITE warranty.
4. *Supplier has to do regular service at the interval of **every Three Months** on site till warranty expires without any additional service charges.*
5. *Supplier has to send the technician for complete installation on site.*
6. The GST registration number and the PAN number of the bidder shall be mentioned in the quotation.
7. GST rate as applicable shall be mentioned clearly.
8. The rate quoted shall be valid for 90 days for its acceptance.
9. The quotation/ bid shall be accepted as a whole or parts thereof depending on the lowest rate quoted for individual items. The bidder shall supply the machine accordingly.
10. The machine should be supplied within 30 days from the date of confirmation acceptance of the quotation.
11. The machine supplied should be strictly as per the specifications specified, without which the machine will be rejected.
12. No advance payment will be made. The payment shall be made immediately on receipt of materials in good working condition. No interest will be made for delayed payment if any.
13. The rate quoted should be firm. No claim for enhancement of rate is admissible after opening of the Quotation.
14. Terms and Conditions stipulated in this Notice Inviting conditions are binding on the bidder. Quotations with conditions in contrary to this NIQ are liable for rejection.
