Instructions to the Candidates**A. Physical Reporting and Admission**

The physical reporting, document verification, and admission process for all candidates allotted a seat at NITK Surathkal through DASA 2026 is scheduled for **17 August 2026**.

Candidates must complete their online enrolment through the NITK IRIS Portal before reporting to campus. Login credentials for the NITK IRIS Admission Portal will be sent to candidates by email on or after **13 August 2026**.

Candidates are required to log in to the NITK IRIS Admission Portal at <https://iris.nitk.ac.in/admission/admissions/login>, fill in the required details, upload the prescribed documents, and pay the applicable Institute fee and Hostel fee online through IRIS before final physical reporting and admission.

The following documents must be uploaded in original on the IRIS portal. Candidates must also bring the original documents along with Admission application form downloaded from the IRIS portal and Fee payment receipts (Institute & Hostel) during physical verification.

1. Provisional admission letter downloaded from the DASA portal.
2. JEE Main scorecard
3. JEE Main admit card.
4. Original certificate of date of birth issued by a competent authority, or Class X High School Board certificate as proof of date of birth.

5. Original Class XII mark sheet.
6. Proof of two years of education, Class XI and Class XII or equivalent, in a foreign country in case of NRI or Indian National candidates.
7. Passport of the student.
8. Visa of the student, for foreign nationals, or OCI card, if applicable.
9. Passport of the parent employed in Gulf countries, for CIWG candidates only.
10. Parent's valid visa, for CIWG candidates only.
11. Parent's work permit, for CIWG candidates only.
12. Letter from the company of the parent working in Gulf countries, for CIWG candidates only.
13. Authenticated citizenship card, for applicants who are nationals of Nepal and do not have a passport.
14. Medical fitness certificate in DASA format.
15. Original migration certificate from the last institute or university attended.
16. Original conduct or character certificate from the head of the institution last attended.
17. Original transfer certificate from the head of the institution last attended.
18. 2 nos. Passport-size photographs.
19. Identity proof of parents and their contact number. (Preferably Aadhaar card for Indian citizens)
20. APAAR/ABC ID {for Indian Nationals}

If any certificate is in a language other than English, an English translation of the same must be produced with certification by the competent authority.

Self-attested photocopies of the documents mentioned above must be arranged in the **specified order and submitted at the time of physical reporting for admission.**

B. Hostel Facilities

Hostel room allotment will be done at the time of physical reporting. Candidates may come prepared to stay in the hostel immediately after completing the admission formalities. Mess facility will be available from the date of reporting to the hostel.

C. Fee Details

The balance fee to be paid at the time of physical reporting is as follows:

Hostellers are required to pay the applicable mess fee at the time of admission to the hostel. The mess fee for the first semester is INR 35,310/-.

D. Withdrawal / Refund of Fee

Candidates who do not physically report at NITK on the specified dates after confirming their seat through DASA shall not be eligible to claim a refund of any fee paid through DASA portal.

Candidates who have confirmed their seat through DASA, physically report at NITK, and complete all admission formalities by paying the balance fee through the Institute IRIS portal shall be eligible for refund of only the balance fee paid at NITK, after deduction of a processing fee of INR 1,000/-. This is subject to submission of the withdrawal request

addressed to the Dean (Academic Programs) on or before the closing date of admission, i.e., 17th August 2026 by 5:00 p.m. Such candidates shall not be eligible for refund of the fee paid through the DASA portal.

Withdrawal requests must be sent to ar.academic@nitk.edu.in or in person on or before **17 August 2026, 05:00 PM**.

Candidates who withdraw admission on or after **17th August 2026, 05:00 PM** shall be eligible for refund of only the caution deposit paid to the Institute. They shall not be eligible for refund of any other fee. Candidates who leave the course after joining shall not be eligible for any refund.

E. Induction Programme and Commencement of Classes

Classes for first-semester B.Tech. students for the academic year 2026–27 will commence from Monday, 24th August 2026. The Induction programme will be held from 18th to 22nd August 2026. The academic calendar will be made available soon on the website.

F. Banking Facility

SBI and Canara Bank branches with ATM facilities are available on campus. All students must compulsorily open a savings bank account in either of the above two branches and inform the Academic Section of their savings bank account number.

G. How to reach NITK

The National Institute of Technology Karnataka (NITK) is located in Mangaluru, Karnataka, India. It is situated along the Kanyakumari–Mumbai National Highway 66. Mangaluru, also known as Mangalore, is a coastal city in the southwestern part of Karnataka.



Mangalore Junction & Mangalore Central Railway Station is located about 20 km from the campus and provides convenient rail access. In addition, Surathkal Railway Station, located approximately 3 km from the campus, further enhances connectivity for the NITK community. Mangalore International Airport, Bajpe, is also located about 20 km from the campus and serves as an important link to domestic and international destinations, making travel convenient for students, faculty, and visitors.
